Dear Director Nua:

We have conditionally approved the American Samoa's application for Federal fiscal year (FFY) 2023 funds under Part C of the Individuals with Disabilities Education Act (IDEA Part C). Our conditional approval is based on our review of the IDEA Part C application, submitted by the American Samoa Department of Health (ASDOH) to the U.S. Department of Education (Department), Office of Special Education Programs (OSEP), on May 26, 2023, and June 22, 2023. The effective date of this grant award is July 1, 2023.

Our conditional approval of the American Samoa Department of Health's FFY 2023 IDEA Part C grant is also based on the American Samoa's policies, procedures, methods, descriptions, assurances, and certifications identified in Section II.A, II.B, and II.C, which is incorporated by reference to this grant award letter as Enclosure A.

Our conditional approval is also based on the ASDOH's certification in Section II.D of its FFY 2023 IDEA Part C application (Enclosure B), in which the American Samoa certifies under 34 C.F.R. § 76.104 that it will:

1. Operate throughout the period of the FFY 2023 grant award consistently with the requirements of IDEA Part C as found in 20 U.S.C. §§ 1431 through 1443 and the regulations in 34 C.F.R. Part 303; and
2. Make such changes to existing policies, procedures, methods, and descriptions as are necessary to bring those policies, procedures, methods and descriptions into compliance with the requirements of IDEA Part C, as soon as possible, and not later than either the date indicated by the American Samoa in Section II.A or B of its application or June 30, 2024, whichever is earlier.

OSEP's conditional approval of American Samoa's FFY 2023 IDEA Part C application is also based on our approval of the transition interagency agreement under Section II.A.10. OSEP has approved the "Memorandum of Understanding between the American Samoa Department of Health and the American Samoa Department of Education Regarding Transition from Part C to Part B under the Individuals with Disabilities Education Act," as reflected in OSEP's memo dated February 3, 2023.

In addition, our approval is based on ASDOH's submission of the form required under Section 427 of the General Education Provisions Act (GEPA). Going forward, for future IDEA grant applications, ASDOH annually review and, if necessary and appropriate, revise its GEPA Section 427 form and submit the revised form as part of its grant application.

American Samoa’s FFY 2023 IDEA Part C grant award is also being released subject to the fiscal Specific Conditions referenced in the Department’s June 29, 2023 letter to American Samoa (which is Enclosure C and incorporated by this reference to this grant letter). These Department-wide Specific Conditions regarding the Single Audit Act are imposed under IDEA sections 616(g) and 642 and 2 CFR §§ 200.208 and 3474.10. The Department is imposing Specific Conditions on American Samoa’s Government for all Department grants to the American Samoa to ensure fiscal accountability of Department grant funds. By accepting this grant award, American Samoa agrees to comply with the Specific Conditions identified in Enclosure C throughout the period American Samoa uses its IDEA Part C FFY 2023 funds.

As part of the American Samoa application for IDEA Part C FFY 2023 funds, American Samoa has provided a certification, under Section II.D of its FFY 2023 application and pursuant to 34 C.F.R. § 76.104, that it will comply with all applicable Federal statutes and regulations in effect during the FFY 2023 grant period.

Enclosed is the American Samoa’s FFY 2023 grant award for funds currently available under the Consolidated Appropriations Act, 2023 (Public Law 117-328) for the IDEA Part C program. These funds are available for obligation by IDEA grant recipients from July 1, 2023 through September 30, 2025 in accordance with 34 C.F.R. § 76.709.

Under IDEA Section 605, and 2 C.F.R. Part 200, and 34 C.F.R. § 303.104, ASDOH must obtain prior approval to charge certain expenses as direct costs.¹ ASDOH identified rent costs in Section III of its application and OSEP will address those costs under separate cover. OSEP’s approval of the FFY 2023 IDEA Part C grant application does not constitute approval for such costs. Please contact your OSEP State Lead for further assistance.

Section IV.B of the IDEA Part C FFY 2023 application requested updated information about how your lead agency implements the restricted indirect cost rate requirements in 34 C.F.R. § 303.225(c). American Samoa indicated in Section IV.B that ASDOH has or had a restricted indirect cost rate of 11.8% that expired on September 30, 2022, and American Samoa’s lead agency is in the process of negotiating a new restricted indirect cost rate that will be in effect for the FFY 2023 grant period. ASDOH may continue to charge its previously approved restricted indirect cost rate of 11.8% once ASDOH submits its restricted indirect cost rate proposal for FFY 2023 and requests an extension; until then, ASDOH may not charge indirect costs to its FFY 2023 IDEA grant award. Also, when a final restricted indirect cost rate is approved by your cognizant Federal agency for FFY 2023, please forward a copy of it to the Department’s Indirect Cost Division and to your OSEP State Lead.

Section 604 of the IDEA provides that “[a] State shall not be immune under the 11th amendment to the Constitution of the United States from suit in Federal court for a violation of this [Act].” Section 606 provides that each recipient of assistance under IDEA make positive efforts to employ and advance in employment qualified individuals with disabilities in programs assisted under the IDEA. Therefore, by accepting this grant, the American Samoa is expressly agreeing as a condition of IDEA funding to a waiver of Eleventh Amendment immunity and to ensuring

that positive efforts are made to employ and advance employment of qualified individuals with disabilities in programs assisted under the IDEA.



If the American Samoa adopts a new or revised IDEA Part C policy or procedure that is required under Part C of the IDEA or under the regulations in 34 C.F.R. Part 303, it must subject those policies and procedures to the public participation requirements in 34 C.F.R. § 303.208 and, for those policies and procedures specifically referenced in 34 C.F.R. § 303.101(c), receive OSEP approval prior to their implementation.

As a reminder, all prime recipients of IDEA Part C funds, must report subaward information as required by the Federal Funding Accountability and Transparency Act of 2006 (FFATA), as amended in 2008. First-tier subaward information must be reported by the end of the following month from when the award was made or obligated. FFATA guidance is found at <https://www.frs.gov/>. These specific conditions apply to all grants awarded by the Department to ASG on or after the date of these specific conditions.

The conditions also apply to all grants under the following programs awarded to any ASG agencies for FFY 2024: Vocational Rehabilitation (Title I of the Rehabilitation Act of 1973 (Rehabilitation Act)), Supported Employment (Title VI of the Rehabilitation Act), Client Assistance Program (section 112 of the Rehabilitation Act), Protection and Advocacy of Individual Rights (section 509 of the Rehabilitation Act), and Independent Living Services for Older Individuals Who Are Blind (Title VII, Chapter 2 of the Rehabilitation Act) (collectively, Rehabilitation Act programs).

These specific conditions are also applicable to grant funds previously awarded by the Department to ASG that are still available for obligation or liquidation as of the date of these specific conditions.

Successful implementation and maintenance of a comprehensive and reliable financial and accounting system is a key element in accomplishing effective fiscal management and administration of Department grants. The specific conditions below are intended to facilitate this effort. In an effort to address systemic internal control deficiencies and limited capabilities of its core financial and accounting system, Integrated Financial and Accounting System (IFAS), at the beginning of fiscal year (FY) 2016, ASG initiated a two-year project - OneSolution upgrade for IFAS.

However, ASG has not yet demonstrated it has effectively resolved deficiencies in internal controls over timely reconciliations of various financial and accounting data to source documents to generate reliable financial reports for management review. Therefore, ASG's status as a "high-risk" grantee remains in effect under the Department's authority in 2 CFR §§ 200.207 and 3474.10. We look

American Samoa Government – Specific Conditions
Federal Fiscal Years (FFY) 2023 and 2024¹

PREAMBLE: These specific conditions are imposed on all grants issued by the U.S. Department of Education (Department) for FFY 2023 to all recipient agencies of the Government of American Samoa (ASG) (including, but not limited to, the American Samoa Department of Education (ASDOE) and the American Samoa Department of Health (ASDOH)) and apply to all grants awarded by the Department to ASG (including, but not limited to, ASDOE and ASDOH) on or after the date of these specific conditions. These specific conditions also apply to all grants under the following programs awarded to any ASG agencies for FFY 2024: Vocational Rehabilitation (Title I of the Rehabilitation Act of 1973 (Rehabilitation Act)), Supported Employment (Title VI of the Rehabilitation Act), Client Assistance Program (section 112 of the Rehabilitation Act), Protection and Advocacy of Individual Rights (section 509 of the Rehabilitation Act), and Independent Living Services for Older Individuals Who Are Blind (Title VII, Chapter 2 of the Rehabilitation Act) (collectively, Rehabilitation Act programs).

Additionally, the specific conditions apply to grant funds previously awarded by the Department to ASG (including, but not limited to, ASDOE and ASDOH) that are still available for obligation or liquidation on the date of these specific conditions. These specific conditions are applied to these program grants and funds in accordance with regulations governing specific conditions and “high-risk” grantees in 2 CFR §§ 200.207 and 3474.10 in the Office of Management and Budget’s Uniform Administrative Requirements, Cost Principles, and Audit Requirements for Federal Awards (Uniform Guidance). The specific conditions are imposed to help ensure that ASG’s awards are expended in accordance with applicable legal requirements and with appropriate fiscal accountability measures, management practices, and controls.

I. EXPLANATION OF HIGH-RISK STATUS

Under the authority of the Uniform Guidance at 2 CFR §§ 200.207 and 3474.10, the Department has determined that ASG continues to be a “high-risk” grantee for purposes of these grant awards because of continuing problems in ASG’s fiscal and program accountability and related areas. Our conclusion is based on the following: the Department continues to be concerned about internal control deficiencies and material weaknesses in the operation of ASG’s internal control structure related to general accounting and grants administration. However, the Department is encouraged by ASG’s Fiscal Year (FY) 2020 audit report, which included an unqualified opinion over financial statements and Federal Department of Education major programs, as well as by ASG’s progress in implementing the corrective actions in its High-Risk Corrective Action Plan (HRCAP), as detailed in section II.A below. The Department looks forward to working with ASG as it continues its progress in completing the remaining corrective actions in its

specific conditions including: physical inventory, fixed assets, trial balances, Federal funds policies and procedures and expansion of the One Solution system.

While recognizing the progress that ASG has made, because there are remaining deficiencies that ASG must address related to the management of Department funds, the Department is again imposing these specific conditions for FFY 2023 and for FFY 2024 for Rehabilitation Act programs, as set forth below.

II. SPECIFIC CONDITIONS

A. High-Risk Corrective Action Plan

1. ASG has made noted progress toward implementing all corrective actions in the HRCAP over the years. The Department has closed 12 action items from ASG's HRCAP including seven last year. Nine action items remain open, and the Department expects to review ASG's progress on, and confirm the implementation of, items 11.4 (Operational policies for monitoring Federal funds) and 15.2 (Expansion of OneSolution to all ASG agencies) during the planned September 2023 monitoring visit. The Department will also review other open items during the visit, as time permits.
2. ASG is required to continue to provide a semiannual report to the Department on its progress in implementing measures required pursuant to the HRCAP. The semiannual reports must include the current status of ASG's implementation of its remaining measures, including a description of activities and progress for each task during the reporting period, documentation of measures of performance and results, and other data or documentation as specified within the action steps for each task, and, if necessary, any changes in the targeted completion dates and/or person(s) responsible for ensuring that a particular corrective action is implemented. ASG must include in each semiannual report all edits and updates from each of its departments into one consolidated HRCAP report.
3. ASG must continue to submit the HRCAP reports to the Department no later than thirty days after the end of each semiannual period. Therefore, semiannual reports shall be submitted to the Department by April 30, 2024, for the period covering October 1, 2023, to March 31, 2024, and by October 31, 2024, for the period covering April 1, 2024, to September 30, 2024. ASG must ensure that its HRCAP report submissions are timely. If a report is not timely or is not considered acceptable by the Department, it may result in the Department taking one or more additional actions or imposing additional remedial requirements, including the following, for any applicable program(s): the reinstatement of quarterly reporting; the imposition of further conditions; the recovery of misspent funds; or the requirement for ASG to procure the services of a third-party fiduciary agent to provide fiscal management services.

Until such time as the remaining corrective actions in the HRCAP have been implemented and deficiencies and material weaknesses have been addressed, semiannual HRCAP

reports will continue to be required as stipulated above.

B. Single Audits

ASG shall continue to ensure that single audits are conducted on an annual basis in a timely manner and that reports, along with data collection forms, are submitted to the Federal Audit Clearinghouse within nine months after the end of each fiscal year. As such, ASG must complete its FY 2022 single audit timely and submit it to the Federal Audit Clearinghouse by June 30, 2023, in accordance with the Single Audit Act of 1984, as amended. The Department will continue to rely on ASG's single audits, along with monitoring conducted by the Department, to perform oversight of ASG's administration of Department grants. If, for any reason, ASG expects an audit or report to be delayed, it shall notify the Department of the reason and extent of the delay as soon as possible. Based on the information provided, the Department may take one or more additional actions or impose additional remedial requirements, including, but not limited to, the imposition of further conditions, the recovery of misspent funds, or the implementation of a contract with a third-party fiduciary agent to provide services.

C. Program-Specific Conditions

Program-specific conditions may be imposed on FFY 2023 grant awards (or FFY 2024 grant awards for Rehabilitation Act programs) made under one or more Department programs, in addition to the specific conditions that are contained in this document. Each such program-specific condition will be contained in a separate attachment to the grant award notification document provided by the Department to ASG.

D. Prompt Access

ASG shall promptly provide the Department with access to any requested staff, locations, records, and information associated with Federal and matching funds related to programs administered by the Department.

E. Failure to Comply with Conditions or Other Requirements

If the Department determines that ASG has not made substantial progress in meeting the objectives of the programs or has not met program requirements or the specific conditions contained in Sections II.A-D above, then the Department may consider not continuing the grant(s), taking further enforcement action steps, or applying additional conditions such as, but not limited to, the following:

1. ASG would receive no further funds under the grant award(s) or only on a reimbursement basis;
2. ASG would be required to prepare and submit a separate corrective action plan for each program in which problems have occurred or in which there is insufficient

progress; and

3. ASG would contract with a third-party fiduciary agent, which must be approved by the Department, to provide services or financial management under the grant award(s). The third-party fiduciary agent would, at a minimum, assist in preparing the vouchers to be submitted to the Department for reimbursement, and would verify their accuracy and legitimacy as an appropriate expenditure under the grant award(s).

These terms and conditions do not preclude the Department from taking any otherwise authorized enforcement or other actions at any time.

III. OTHER TERMS

A. Submission of Reports

All reports and plans (including with respect to the HRCAP) that are required to be submitted by ASG to the Department under these specific conditions shall be submitted in electronic file format to Patrick Smith, Risk Management Specialist at patrick.smith@ed.gov. B. Reconsideration and Modifications

At any time, ASG may request reconsideration of the above specific conditions by contacting the Department and stating reasons why ASG believes particular conditions are no longer needed. Additionally, the Department may impose additional specific conditions or modify these specific conditions as appropriate. The Department will remove the specific conditions at such time as ASG meets, to the Department's satisfaction, the conditions contained herein.
