# **Counting What Counts in Clery**

#### Facts:

- For each category (primary and Hate Crimes), 2011 Handbook has us count incidents in residence halls twice, 1 On Campus; 1 On Campus Residential
- 2011 Handbook has us double count Hate Crimes in Part I (now called Primary) crimes and in Hate Crimes
- VAWA proposed regulations has us separately count domestic violence, dating violence and stalking crimes
- VAWA proposed regulations exempts sexual assault from the hierarchy stating, "[i]n reporting incidents of sexual assault, the Hierarchy Rule does not apply." This is not limited to a single incident of sexual assault, if the hierarchy does not apply to incidents of sexual assault, it is conceivable that we would report multiple different kinds of assault, as well as the graver crime in the Hierarchy.
- Department of Education has said again and again that overcounting crimes is as bad as counting crimes, but its own rules demand overcounting.
