New! C SPR Part II Warnings C SPR-2001 – C SPR-2007 in Section 2.1.1.1

The defects in the C SPR-2001 through C SPR-2007 edit checks have now been resolved. If you have already completed this section, please review the section again to ensure that you have addressed any error messages.

NEW! C SPR Section 2.4 Load Time

While navigating C SPR Section 2.4, users may be experiencing slowness as well as the message “ED.gov has stopped responding”. The reason for the slowness is due to the amount of prefill data included in this section. Our Systems Infrastructure team is currently working on a resolution. In the meantime, please allow all data to load completely before navigating this section. Once the data has completely loaded, users should be able to navigate without incident.

NEW! C130 SY 2013-14 Required To Be Submitted for C SPR 2.12 Reports

In order to complete section 2.12 of the C SPR, States must submit the SY 2013-14 C130 (ESEA Status) file. Please note that this is the only SY 2013-14 file required for the SY 2012-13 C SPR.

Unlike other C SPR sections, the data for section 2.12 does not appear in the C SPR Collection Tool located in the ESS Portal. Instead, the lists of schools and districts are displayed through the EDEN030-035 reports located in the C SPR tab of the ED Facts Reporting System (ERS). These reports are populated with statuses from the SY 2013-14 C130 file and various other data from SY 2012-13 files. Before certifying the C SPR, SEA staff must submit the ED Facts files that populate the EDEN030-035 reports, run the reports in ERS, and verify that the lists of schools and districts are correct. The files are due at 8:00 p.m. on Thursday, February 13 along with other Part II files, but in order to see the data in the reports and allow time for corrective

submissions, states should try to submit prior to the deadline. Once the data have been verified, users should log into the CSPR Collection Tool in ESS and mark Section 2.12 as “finished”.

NEW! Part B Child Count and Educational Environments Due April 2, 2014 and Signed Certification Form

OSEP wants to remind all states that the IDEA Part B Child Count/Educational Environments and Part C Child Count/Settings due date is now the first Wednesday in April, starting in 2014 (SY 2013-14).

To meet the Child Count data collection requirements, please have the authorized official of the agency complete and sign the attached form as a certification that the Child Count data submitted by your State is an accurate and unduplicated count of children with disabilities receiving special education and related services on the State designated child count date. The completed and signed form should be submitted electronically via email to the Partner Support Center (PSC) at EDEN_SS@ed.gov or by fax to PSC at the number below. Please send the document by April 2, 2014 (the same day the Child Count files are due).

Reminder: SY 2012-13 CSPR Recommended Browsers for EDEN Portal Applications

This is a reminder that Internet Explorer, versions 9 and earlier, are the supported and recommended browsers for EDEN Portal applications.

If you are currently using Internet Explorer 10, the majority of validation errors may not appear onscreen where you expect to see edit check messages. We recommend utilizing compatibility mode for Internet Explorer 10. If you are not familiar with compatibility mode, feel free to contact PSC and we will walk you through this process. Alternatively, you may roll back to Internet Explorer 9. Please contact your internal IT department for assistance with this process. Once you have either enabled compatibility mode or rolled back to Internet Explorer 9, please recheck your CSPR sections to ensure that you have addressed all necessary validation errors.

Other browsers may also be displaying incomplete error messages. If you are using any other browsers to access your CSPR, we recommend switching over to Internet Explorer 9 and rechecking your sections to ensure that you have fully addressed all necessary validation errors.

Reminder: SY 2012-13 CSPR Part II Certification Due on February 14, 2014

Part II of the SY 2012-13 Consolidated State Performance Report (CSPR) must be certified by 5 p.m., EST on **February 14, 2014**. All *EDFacts* files that populate Part II must be submitted by 8 p.m., EST on **February 13, 2014**
