
### **About the Civil Rights Data Collection**

It gathers information about student access to educational programs, activities, staff, and school climate factors from public schools serving students in preschool through 12th grade. 

#### During the 2020-21 school year, 88% of schools offered a hybrid of in-person and virtual instruction in response to the coronavirus pandemic, 6% of schools offered only in-person


instruction, and 5% of schools offered virtual instruction only. Only 1% of schools reported that the pandemic had no effect on instruction.
