## **Resolution Agreement**

Dallas County Community College District OCR Reference No. 06-18-2035

To resolve the above-referenced complaint brought under Section 504 of the Rehabilitation Act of 1973 and Title II of the Americans with Disabilities Act of 1990, the Office for Civil Rights (OCR) of the U.S. Department of Education and the Dallas County Community College District (DCCCD) enter into the following agreement. This agreement supersedes the agreement the DCCCD entered into on February 8, 2018. This agreement was entered into voluntarily and does not constitute an admission of liability, non-compliance, or wrongdoing by the DCCCD.

- 1. <u>Current Online Content and Functionality</u>. By May 1, 2020, the DCCCD agrees that it will take all actions necessary to ensure that individuals with disabilities have an equal opportunity to participate in the DCCCD's programs and activities offered through the DCCCD's website and the websites of the DCCCD's campuses or equally effective alternate access. To meet this commitment, the DCCCD will: develop a strategy for identifying inaccessible content and functionality for individuals with disabilities; develop a notice to persons with disabilities regarding how to request that the DCCCD provide access to online information or functionality; prominently post this notice on its home page and throughout its website, including throughout the websites of its campuses; and develop a process to ensure that, upon request, inaccessible content and functionality will be made accessible<sup>1</sup> in an expedient manner.
- 2. <u>New Online Content and Functionality</u>. By August 8, 2018, the DCCCD will establish a plan to ensure that all new online content and functionality developed, procured, or used after the date of this agreement will be fully accessible to individuals with disabilities. The plan should include any staff training that may be necessary to ensure full implementation with the plan.
- 3. <u>Undue Burden and Fundamental Alteration</u>. This agreement does not require the DCCCD to take any action that it can demonstrate would result in a fundamental alteration in the nature of a service, program, or activity or in undue financial and administrative burdens. In those circumstances where the DCCCD can demonstrate compliance would result in such an alteration or burden, the DCCCD will ensure that, to the maximum extent possible, individuals with disabilities receive the benefits or services provided by the DCCCD.
- 4. <u>Technical Assistance</u>. OCR will make itself available to provide technical assistance to the DCCCD during the DCCCD's implementation of this agreement.
- 5. <u>Reporting Provision</u>. By May 1, 2020, the DCCCD will submit a report to OCR demonstrating that it has fully satisfied the terms of this agreement. The report will

describe benchmarks the DCCCD has reached, and on-going efforts to maintain web accessibility and usability of the DCCCD's website and the websites of its campuses.

The DCCCD understands that by signing the Agreement, it agrees to provide data and other information in a timely manner in accordance with the reporting requirement of this Agreement. Further, the DCCCD understands that during OCR's monitoring of this Agreement, if necessary, OCR may visit the DCCCD, interview staff and students, and request such additional reports or data as are necessary for OCR to determine whether the DCCCD has fulfilled the terms of this Agreement. Upon the DCCCD's satisfaction of the commitments made under this Agreement, OCR will close the case.

The DCCCD understands and acknowledges that OCR may initiate administrative enforcement, or judicial proceedings to enforce the specific terms and obligations of this Agreement. Before initiating administrative enforcement (34 C.F.R. §§ 100.9, 100.10), or judicial proceedings to enforce the Agreement, OCR will give the DCCCD written notice of the alleged breach and sixty (60) calendar days to cure the alleged breach

This agreement will become effective immediately upon the signature of the DCCCD's representative below.
