**RE:** Supplement to Adult Education State Awards for Fiscal Year (FY) 2014

The Office of Career, Technical, and Adult Education (OCTAE) has received a reapportionment of excess FY 2014 Adult Education incentive grant funds and awarded them as a grant supplement to each State's FY 2014 grant amount under the Adult Education and Family Literacy Act (AEFLA), Title II of the Workforce Investment Act of 1998 (WIA). In accordance with Section 211(a)(3) of WIA, 1.72 percent of the AEFLA appropriation was reserved for FY 2014 incentive grants under section 503. The amount reserved was \$9,935,872. Of that amount, \$9,000,000 was made available to three states that qualified for incentive grants under the FY 2014 appropriation, leaving a balance of \$935,872. OCTAE has allocated the remaining balance of \$935,872 as grant supplements under the AEFLA State Grant program based on the formula in Section 211 of AEFLA.

The attached table shows the amount each State was awarded as a supplement to its FY 2014 AEFLA State Grant award. These funds are immediately available and may be obligated until September 30, 2016, in accordance with the provisions of Title II under WIOA.
