SUBJECT: Redelegation of Authority for Grants and Cooperative Agreements

# I. <u>DELEGATION OF AUTHORITY</u>

Under the authority vested in me from the Secretary by delegation EA/EAR/165, certified on March 26, 2008, and except as noted in section II below, I delegate to you, to your successor in function, and to anyone serving for you in an acting capacity, the authority to perform functions related to the award, management and oversight of formula and discretionary grants and cooperative agreements within your programmatic authority. This includes the authority to take any action as deemed appropriate and necessary to manage and mitigate risks associated with high risk or at-risk grants and grantees, within your programmatic authority.

Unless otherwise noted in future delegations of authority, amendments to the authority delegated in this document are included within the scope of this delegation.

## II. <u>RESERVATIONS</u>

Unless otherwise noted in existing or future delegations of authority, the following are not delegated:

- A. The authority to set administrative policy for formula and discretionary grants and cooperative agreements, including issuing Department directives, handbooks, and manuals relating to grants and cooperative agreements.
- B. The authority to impose non-procurement debarments and suspensions and to manage enforcement of non-debarments and suspensions.

Page 2 - Redelegation of Authority for Grants and Cooperative Agreements

- C. The authority to issue licenses to individuals to record obligations and award grant funds for discretionary grants and cooperative agreements.
- D. The authority as final arbiter on cross-Department risk management strategies developed to manage and mitigate risks associated with Department high-risk or at-risk grants and grantees.

### III. <u>REDELEGATION</u>

You may redelegate the authority delegated to you.

## IV. <u>CERTIFICATION AND EFFECTIVE DATE</u>

This delegation is effective upon certification by the Department's Principal Delegations Control Officer and supersedes all previous delegations of this authority. I ratify actions within the scope of this delegation taken by the addressees prior to the date of certification.
