### I. <u>DELEGATION</u>

By the authority vested in me by section 412 of the Department of Education Organization Act, Public Law 96-88, 20 U.S.C. 3472, I hereby delegate to you the authority to act as the designated Deciding Debarment and Suspension Official (Deciding DSO) for purposes of considering and imposing debarments, and reviewing and affirming suspensions, against lenders, guarantee agencies, thirdparty servicers, institutions of higher education, or a person who is a principal of a lender, guarantee agency, third-party servicer, or institution of higher education.

The authority to act as the Deciding DSO is to be exercised in accordance with Executive Order 12549, "Debarment and Suspension," published in the Federal <u>Register</u> on February 21, 1986 (51 FR 6370), and with the Department of Education's implementing regulations at 34 CFR Part 85. This authority also is to be exercised in accordance with the procedures for conducting nonprocurement debarment and suspension actions issued under the Administrative Communications System, Departmental Directive C:GPA:1-105 (September 25, 1991), except that a Deciding DSO in OHA is not required to seek General Counsel review prior to issuing decisions involving lenders, guarantee agencies, third-party servicers, institutions of higher education, or a person who is a principal of a lender, guarantee agency, third-party servicer, or institution of higher education.

Unless otherwise noted in future delegations of authority, amendments to executive orders, regulations, directives, or other documents relating to the authority delegated herein are included within the scope of this delegation.

# II. <u>RESERVATIONS</u>

Unless otherwise noted, the following authority is not delegated:

- (1) the authority to sign <u>Federal Register</u> documents; and,
- (2) unless otherwise provided by law, the authority to submit reports to Congress or the President.

### III. <u>REDELEGATION</u>

This authority may be redelegated to hearing officials assigned to or employed within the Office of Hearing and Appeals. No further redelegation is permitted.

# IV. <u>CERTIFICATION AND EFFECTIVE DATE</u>

This delegation is effective upon certification by the Department's Principal Delegation Control Officer and supersedes all previous delegations of this authority.

I hereby ratify any actions by OHA hearing officials within the scope of this delegation taken prior to the date of certification.
