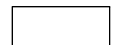

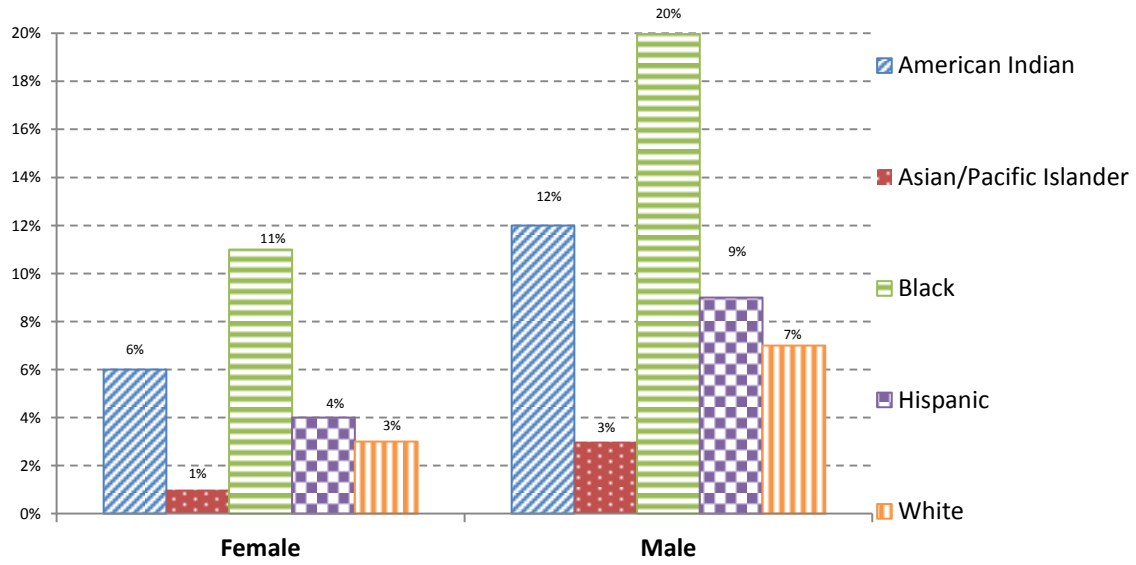

Exhibit 9: Growing Case of Load of Compliants Recieved Acorss a 40-Year Spectrum, FY 1982–2012

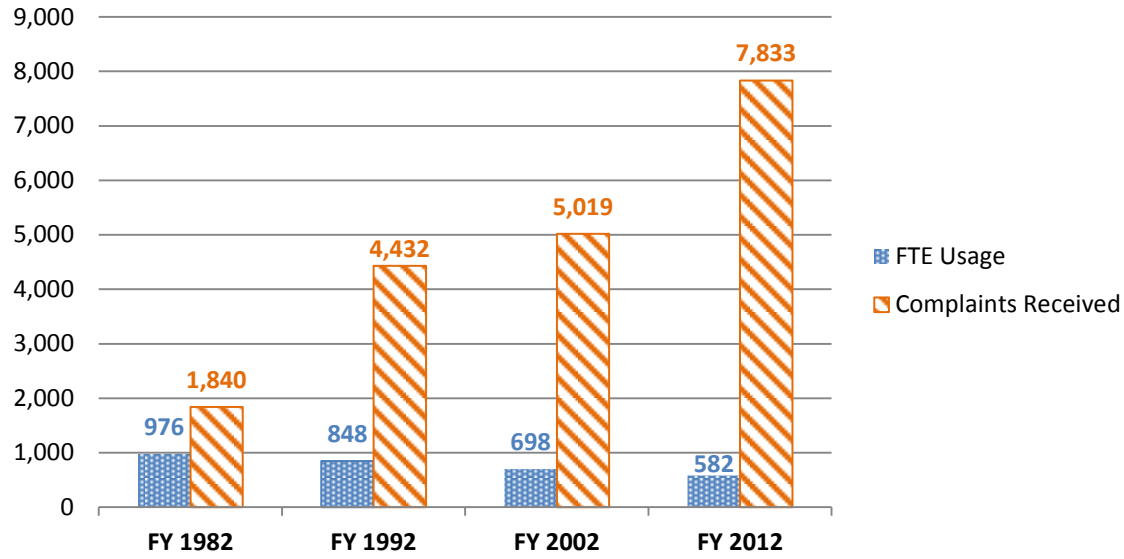
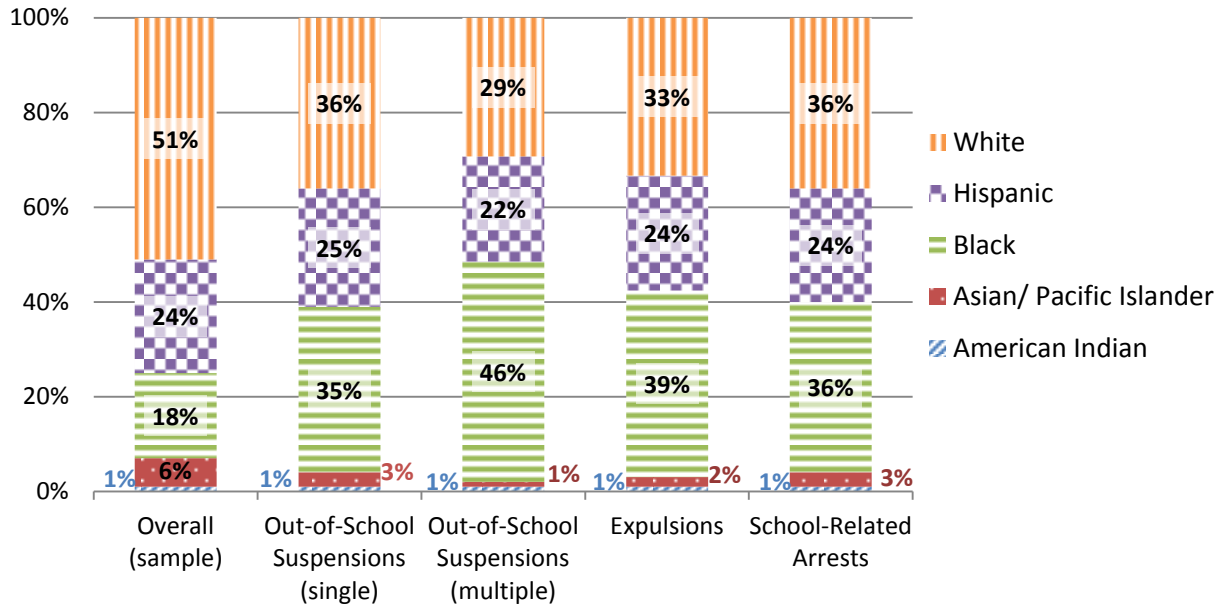


Exhibit 12: Disparities in Discipline by Race and Ethnicity, 2009–10
