## Alaska Part B FFY 2011 Results Data Summary Notes

INDICATOR 1: The State revised the improvement activities for FFY 2011 and FFY 2012 for this indicator and OSEP accepts those revisions.

INDICATOR 2: The State revised the improvement activities for FFY 2011 and FFY 2012 for this indicator and OSEP accepts those revisions.

INDICATOR 3A: The State has applied for, but not yet received approval for, a flexibility waiver under the Elementary and Secondary Education Act (ESEA). The State is reporting AYP data used for accountability reporting under Title I of the ESEA.

INDICATOR 3B: The State provided a Web link to 2011 publicly-reported assessment results.

The State did not report publicly on the participation of children with disabilities on statewide assessments with the same frequency and in the same detail as it reports on the assessments of nondisabled children, as required by 34 CFR §300.160(f). Specifically, for the High School Graduation Qualifying Examination, the State has not reported the number of children with disabilities in regular assessments who were provided accommodations (that did not result in an invalid score) in order to participate in those assessments at the district and school levels. The failure to publicly report as required under 34 CFR §300.160(f) is noncompliance.

The State was first notified of this noncompliance in the FFY 2009 Response Table. In the FFY 2010 APR, the State reported that it would begin to collect the required data by November 2012. In the FFY 2011 APR, the State reported that “the data will not be available for public reporting until FFY 2013. Alaska will report the data, as required, at that time.”

### **REQUIRED ACTIONS**

With the FFY 2012 APR, the State must provide a Web link that demonstrates it has reported, for FFY 2012, to the public on the statewide assessments of children with disabilities in accordance with 34 CFR §300.160(f). OSEP is not requiring the State to also provide, with its FFY 2012 APR, a Web link demonstrating that it reported all of the required data for FFY 2011, because the State has informed OSEP that the data are not available.

INDICATORS 3C: The State provided a Web link to 2011 publicly-reported assessment results.

INDICATOR 4A: The State revised the improvement activities for FFY 2011 and FFY 2012 for this indicator and OSEP accepts those revisions.

The State reported its definition of “significant discrepancy.”

The State reported that two districts were identified as having a significant discrepancy in the rate of suspensions and expulsions of greater than ten days in a school year for children with IEPs.

The State reported that five of 54 districts did not meet the State-established minimum “n” size requirement of at least ten children with IEPs enrolled in the school district.

The State reported that it reviewed the districts’ policies, procedures, and practices relating to the development and implementation of IEPs, the use of positive behavioral interventions and supports, and procedural safeguards to ensure compliance with the IDEA, as required by 34 CFR §300.170(b) for the districts identified with significant discrepancies in FFY 2011. The State did not identify noncompliance through this review.

INDICATOR 4B: The State revised the improvement activities for FFY 2011 and FFY 2012 for this indicator and OSEP accepts those revisions. The State reported its definition of “significant discrepancy.”

The State reported that six districts were identified as having a significant discrepancy, by race or ethnicity, in the rate of suspensions and expulsions of greater than ten days in a school year for children with IEPs. The State reported that it reviewed the districts’ policies, procedures, and practices relating to the development and implementation of IEPs, the use of positive behavioral interventions and supports, and procedural safeguards to ensure compliance with the IDEA, as required by 34 CFR §300.170(b) for the districts identified with significant discrepancies in FFY 2010.

The State did not identify any noncompliance through this review.

The State reported that five of 54 districts did not meet the State-established minimum “n” size requirement of at least ten children with IEPs enrolled in any race/ethnicity group identified with a significant discrepancy.

The State also reported that no districts were identified with disproportionate representation of racial and ethnic groups in specific disability categories that was the result of inappropriate identification.

The State reported that 36 of 54 districts did not meet the State-established minimum “n” size requirement of at least ten students with IEPs in the racial/ethnic group of interest (when examining child count data) and at least ten students of the remaining number of all other students who serve as the comparison group for that racial/ethnic group of interest and were excluded from the calculation.
