The State reported that no districts were identified as having a significant discrepancy, by race or ethnicity, in the rate of suspensions and expulsions of greater than ten days in a school year for children with IEPs.

The State reported that none of its districts met the State-established minimum “n” size requirement of “ten students with disabilities who were suspended or expelled for greater than ten days in a school year.”

INDICATOR 9: The State reported that no districts were identified with disproportionate representation of racial and ethnic groups in special education and related services. The State provided its definition of “disproportionate representation.”

The State reported that 218 of 415 districts did not meet the minimum “n” size requirement of “10 students for at least one racial and ethnic group” and were excluded from the calculation.
