The State reported that four districts were identified as having a significant discrepancy in the rate of suspensions and expulsions of greater than ten days in a school year for children with IEPs.

Although the State reported a minimum “n” requirement of ten students with disabilities, the State also reported that data were reviewed separately for LEAs with less than the minimum “n” size to determine if a significant discrepancy in the rate of suspensions and expulsions of greater than ten days in a school year for children with IEPs existed in all LEAs in the State, and that, therefore, the State did not exclude any LEAs from the calculation because they did not meet the minimum “n” size for this indicator.

The State reported that it reviewed the districts’ policies, procedures, and practices relating to the development and implementation of IEPs, the use of positive behavioral interventions and supports, and procedural safeguards to ensure compliance with the IDEA, as required by 34 CFR §300.170(b) for the districts identified with significant discrepancies in FFY 2011. The State did not identify noncompliance through this review.
