INDICATOR 3A: The State is reporting Annual Measurable Objectives (AMOs) data used for accountability reporting under Title I of the Elementary and Secondary Education Act (ESEA) as a result of ESEA flexibility. The State has reported FFY 2012 baseline data based for this indicator based on AMOs.

The State reported that 131 of 134 districts met the State-established minimum “n” size in the special education subgroup. Accordingly, of those 131 districts, 3 met the AMO Targets for both reading/language arts and mathematics in the special education subgroup across all grade levels (elementary, middle and high school.)

INDICATORS 3B and 3C: The State provided a Web link to 2012 publicly-reported assessment results.

INDICATOR 4A: The State reported its definition of “significant discrepancy.”

The State reported that eight districts were identified as having a significant discrepancy in the rate of suspensions and expulsions of greater than ten days in a school year for children with IEPs.

The State reported that it does not use a minimum “n” size requirement.

The State reported that it reviewed the districts’ policies, procedures, and practices relating to the development and implementation of IEPs, the use of positive behavioral interventions and supports, and procedural safeguards to ensure compliance with the IDEA, as required by 34 CFR §300.170(b) for the districts identified with significant discrepancies in FFY 2012. INDICATOR 4B: The State reported its definition of “significant discrepancy.”

The State reported that 10 districts were identified as having a significant discrepancy, by race or ethnicity, in the rate of suspensions and expulsions of greater than ten days in a school year for children with IEPs.

The State reported that three of 132 districts did not meet the State-established minimum “n” size requirement (excluding any LEA that had one or fewer students suspended or expelled) and were excluded from the calculation.

The State reported that it reviewed the districts’ policies, procedures, and practices relating to the development and implementation of IEPs, the use of positive behavioral interventions and supports, and procedural safeguards to ensure compliance with the IDEA, as required by 34 CFR §300.170(b) for the districts identified with significant discrepancies in FFY 2011.

The State also reported that no districts were identified as having policies, procedures or practices that contribute to the significant discrepancy and do not comply with requirements relating to the development and implementation of IEPs, the use of positive behavioral interventions and supports, and procedural safeguards. The State did not identify any noncompliance through this review.

INDICATOR 9: The State reported that six districts were identified with disproportionate representation of racial and ethnic groups in special education and related services. The State also reported that no districts were identified with disproportionate representation of racial and ethnic groups in special education and related services that was the result of inappropriate identification.

The State provided its definition of “disproportionate representation.”

The State reported that four of the 132 districts did not meet the State-established minimum “n” size requirement of ten and were excluded from the calculation.
