### Colorado FFY 2012 Results Data Summary Notes

INDICATOR 3A: The State is reporting Annual Measurable Objectives (AMO) data used for accountability reporting under Title I of the Elementary and Secondary Education Act (ESEA) as a result of ESEA flexibility.

The State did not provide valid and reliable data for this indicator. These data are not valid and reliable because the State did not use the correct measurement. The required measurement is: [(# of districts with a disability subgroup that meets the State's minimum "n" size that meet the State's AMO targets for the disability subgroup) divided by the (total # of districts that have a disability subgroup that meets the State's minimum "n" size)] times 100. Rather, the State provided in the table on page 15 of its FFY 2012 APR, the number of districts meeting the State's AMO targets for the disability subgroup divided by the total number of districts that have a disability subgroup that meets the State's minimum "n" size.

Further, the State did not provide an FFY 2012 its target for this indicator, consistent with the measurement for this indicator, but instead provided its AMO rate.

#### **REQUIRED ACTIONS**

The State did not provide data based on the required measurement and the State must provide the required data based on the required measurement, for FFY 2013 in the FFY 2013 APR.

INDICATOR 3B and 3C: The State provided a Web link to 2011 publicly-reported assessment results.

INDICATOR 4A: The State reported its definition of "significant discrepancy."

The State reported that it does not use a minimum "n" size requirement.

The State reported that one district was identified as having a significant discrepancy in the rate of suspensions and expulsions of greater than ten days in a school year for children with IEPs.

The State reported that it reviewed the district's policies, procedures, and practices relating to the development and implementation of IEPs, the use of positive behavioral interventions and supports, and procedural safeguards to ensure compliance with the IDEA, as required by 34 CFR §300.170(b) for the district identified with a significant discrepancy in FFY 2011. The State did not identify noncompliance through this review.

The State must report progress data and actual target data for FFY 2013 in the FFY 2013 APR.

### Colorado FFY 2012 Compliance Data Summary Notes

INDICATOR 4B: The State reported its definition of “significant discrepancy.”

The State reported that no districts were identified as having a significant discrepancy, by race or ethnicity, in the rate of suspensions and expulsions of greater than ten days in a school year for children with IEPs.

The State reported that all districts met the State-established minimum “n” size requirement of ten students with IEPs suspended/expelled for greater than 10 days in a school year, regardless of race or ethnicity.

The State did not report any noncompliance through this review.

OSEP’s FFY 2011 SPP/APR Response Table required the State to include, in the FFY 2012 APR, an explanation that the districts identified with noncompliance in FFYs 2009 and 2010 had no individual cases of noncompliance, unless the child was no longer within the jurisdiction of the district. The State provided all of the required information.

INDICATOR 9: The State provided its definition of “disproportionate representation.”

The State reported that no districts were identified with disproportionate representation of racial and ethnic groups in special education and related services.

The State reported that all of the districts met the State-established minimum “n” size requirement of 30 students and none were excluded from the calculation.

INDICATOR 10: The State provided its definition of “disproportionate representation.”

The State reported that 21 districts were identified with disproportionate representation of racial and ethnic groups in specific disability categories. The State also reported that one district was identified with disproportionate representation of racial and ethnic groups in specific disability categories that was the result of inappropriate identification.

The State reported that that two of three findings of noncompliance identified in FFY 2010 were corrected. For the uncorrected noncompliance, the State reported on the actions it took to address the uncorrected noncompliance.

The State reported that all of the districts met the State-established minimum “n” size requirement of 30 students, and none were excluded from the calculation.

### **REQUIRED ACTIONS**

Because the State reported less than 100% compliance for FFY 2012 (greater than 0% actual target data for this indicator), the State must report on the status of correction of noncompliance identified in FFY 2012 for this indicator. The State must demonstrate, in the FFY 2013 APR, that the district identified in FFY 2012 with disproportionate representation of racial and ethnic groups in specific disability categories that was the result of inappropriate identification is in compliance with the requirements in 34 CFR §§300.111, 300.201, and 300.301 through 300.311. Further, the State must demonstrate, in the FFY 2013 APR, that the remaining district identified in FFY 2010 with disproportionate representation of racial and ethnic groups in specific disability categories that was the result of inappropriate identification, is in compliance with the requirements in 34 CFR §§300.111, 300.201, and 300.301 through 300.311. The State must report, with the FFY 2013 SPP/APR, that it has corrected the remaining 11 findings of noncompliance identified in FFY 2011, and the one remaining finding identified in FFY 2010 that was not reported as corrected in the FFY 2012 APR.

When reporting with the FFY 2013 APR on the correction of the remaining findings of noncompliance identified in FFY 2011 and FFY 2010, the State must report that it verified that each LEA with remaining findings of noncompliance: (1) is correctly implementing the specific regulatory requirements (i.e., achieved 100% compliance) based on a review of updated data such as data subsequently collected through on-site monitoring or a State data system; and (2) has corrected each individual case of noncompliance, unless the child is no longer within the jurisdiction of the LEA, consistent with OSEP Memo 09-02.
