### Illinois FFY 2012 Results Data Summary Notes

INDICATOR 3A: The State has chosen to continue to report AYP data based on targets established under Title I of the Elementary and Secondary Education Act.

INDICATOR 3B and 3C: The State provided a Web link to 2012 publicly-reported assessment results.

INDICATOR 4A: The State reported its definition of “significant discrepancy.”

The State reported that 133 districts were identified as having a significant discrepancy in the rate of suspensions and expulsions of greater than ten days in a school year for children with IEPs.

The State reported that 90 of 133 districts did not meet the State-established minimum “n” size requirement of at least five students with IEPs suspended or expelled more than ten days in a school year for the past three consecutive years.

The State reported that it reviewed the districts’ policies, procedures, and practices relating to the development and implementation of IEPs, the use of positive behavioral interventions and supports, and procedural safeguards to ensure compliance with the IDEA, as required by 34 CFR §300.170(b) for the districts identified with significant discrepancies in FFY 2012. The State did not identify noncompliance through this review.

The State reported that it identified five findings of noncompliance, based on 2010-2011 discipline data, in FFY 2012 (on September 21, 2012), all of which were timely corrected, and that it identified no findings of noncompliance in FFY 2011.

### Illinois FFY 2012 Compliance Data Summary Notes

INDICATOR 4B: The State reported its definition of “significant discrepancy.”

The State reported that 20 districts were identified as having a significant discrepancy, by race or ethnicity, in the rate of suspensions and expulsions of greater than ten days in a school year for children with IEPs.

The State reported that it reviewed the districts’ policies, procedures, and practices relating to the development and implementation of IEPs, the use of positive behavioral interventions and supports, and procedural safeguards to ensure compliance with the IDEA, as required by 34 CFR §300.170(b) for the districts identified with significant discrepancies in FFY 2011.

The State also reported that no districts were identified as having policies, procedures or practices that contribute to the significant discrepancy and do not comply with requirements relating to the development and implementation of IEPs, the use of positive behavioral interventions and supports, and procedural safeguards.

The State did not identify any noncompliance through this review.

The State reported that 104 of 133 districts did not meet the State-established minimum “n” size requirement of at least five students with IEPs in a particular race/ethnicity suspended or expelled more than ten days in a school year for the past three consecutive years.

The State did not report on whether noncompliance identified in five districts in FFY 2011 through the review of policies, procedures, and practices, pursuant to 34 CFR §300.170(b), was corrected. Although the State reported in its FFY 2011 APR that it identified noncompliance in five districts, the State reported in its FFY 2012 APR that the State identified no findings of noncompliance in FFY 2011.

INDICATOR 9: The State reported that five districts were identified with disproportionate representation of racial and ethnic groups in special education and related services. The State also reported that no districts were identified with disproportionate representation of racial and ethnic groups in special education and related services that was the result of inappropriate identification.

The State provided its definition of “disproportionate representation.”

The State reported that, of 863 LEAs, 682 had at least 10 students with IEPs ages 6-21 for the past three school years (2010-2011, 2011-2012, and 2012-2013). Accordingly, 181 LEAs did not meet the minimum “n” size for further analysis under Indicator 9.

INDICATOR 10: The State reported that 58 districts were identified with disproportionate representation of racial and ethnic groups in specific disability categories. The State also reported that no districts were identified with disproportionate representation of racial and ethnic groups in specific disability categories that was the result of inappropriate identification. The State provided its definition of “disproportionate representation.”

The State reported that, of 863 LEAs, 588 had at least 10 students ages 6-21 for the past three school years (2010-2011, 2011-2012, 2012-2013) in one of the six disability categories. Accordingly, 275 LEAs did not meet the minimum “n” size for further analysis under Indicator 10.

INDICATOR 11:

**REQUIRED ACTIONS**

Because the State reported less than 100% compliance for FFY 2012, the State must report on the status of correction of noncompliance identified in FFY 2012 for this indicator. When reporting on the correction of noncompliance, the State must report, in its FFY 2013 APR, that it has verified that each LEA with noncompliance identified in FFY 2012 for this indicator: (1) is correctly implementing the specific regulatory requirements (i.e., achieved 100% compliance) based on a review of updated data such as data subsequently collected through on-site monitoring or a State data system; and (2) has corrected each individual case of noncompliance, unless the child is no longer within the jurisdiction of the LEA, consistent with OSEP Memo 09-02.<sup>5</sup> In the FFY 2013 APR, the State must describe the specific actions that were taken to verify the correction.

INDICATOR 12: The State reported that 40 findings of noncompliance identified in FFY 2009 were corrected.

**REQUIRED ACTIONS**

Because the State reported less than 100% compliance for FFY 2012, the State must report on the status of correction of noncompliance identified in FFY 2012 for this indicator. When reporting on the correction of noncompliance, the State must report, in its FFY 2013 APR, that it has verified that each LEA with noncompliance identified in FFY 2012 for this indicator: (1) is correctly implementing the specific regulatory requirements (i.e., achieved 100% compliance) based on a review of updated data such as data subsequently collected through on-site monitoring or a State data system; and (2) has corrected each individual case of noncompliance, unless the child is no longer within the jurisdiction of the LEA, consistent with OSEP Memo 09-02. In the FFY 2013 APR, the State must describe the specific actions that were taken to verify the correction.

INDICATOR 13: The State reported that three findings of noncompliance identified in FFY 2010 and the one finding of noncompliance identified in FFY 2009 were corrected.

**REQUIRED ACTIONS**

Because the State reported less than 100% compliance for FFY 2012, the State must report on the status of correction of noncompliance identified in FFY 2012 for this indicator. When reporting on the correction of noncompliance, the State must report, in its FFY 2013 APR, that it has verified that each LEA with noncompliance identified in FFY 2012 for this indicator: (1) is correctly implementing the specific regulatory requirements (i.e., achieved 100% compliance) based on a review of updated data such as data subsequently collected through on-site monitoring or a State data system; and (2) has corrected each individual case of noncompliance, unless the child is no longer within the jurisdiction of the LEA, consistent with OSEP Memo 09-02. In the FFY 2013 APR, the State must describe the specific actions that were taken to verify the correction.

<sup>5</sup> OSEP Memorandum 09-02 (OSEP Memo 09-02), dated October 17, 2008, requires that the State report that it verified that each LEA with noncompliance: (1) is correctly implementing the specific regulatory requirements (i.e., achieved 100% compliance) based on a review of updated data such as data subsequently collected through on-site monitoring or a State data system; and (2) has corrected each individual case of noncompliance, unless the child is no longer within the jurisdiction of the LEA.

INDICATOR 15: The State reported that none of the 12 findings identified in FFY 2010 were corrected. For the uncorrected noncompliance, the State reported on the actions it took to address the uncorrected noncompliance. Further, the State reported that all 41 findings of noncompliance identified in FFY 2009 and the finding of noncompliance identified in FFY 2006 were corrected.

**REQUIRED ACTIONS**

The State must report, with the FFY 2013 SPP/APR, that it has corrected the remaining 12 findings of noncompliance identified in FFY 2010 that were not reported as corrected in the FFY 2012 APR were corrected.

When reporting with the FFY 2013 APR on the correction of the remaining findings of noncompliance identified in FFY 2010, the State must report that it verified that each LEA with remaining findings of noncompliance: (1) is correctly implementing the specific regulatory requirements (i.e., achieved 100% compliance) based on a review of updated data such as data subsequently collected through on-site monitoring or a State data system; and (2) has corrected each individual case of noncompliance, unless the child is no longer within the jurisdiction of the LEA, consistent with OSEP Memo 09-02.

In addition, in responding to Indicators 11, 12, and 13 in the FFY 2013 SPP/APR, the State must report on correction of the noncompliance described in this table under those indicators.
