INDICATOR 4B:

The State reported its definition of “significant discrepancy.”

The State reported that 21 districts were identified as having a significant discrepancy, by race or ethnicity, in the rate of suspensions and expulsions of greater than ten days in a school year for children with IEPs. The State reported that it reviewed the districts’ policies, procedures, and practices to determine whether these contributed to the significant discrepancy or failed to comply with the procedural safeguards of IDEA, and that seven districts were found to be discrepant due to inappropriate or insufficient policies, procedures, or practices.

The State did not specifically report that the review was related to the development and implementation of IEPs, the use of positive behavioral interventions and supports, and procedural safeguards to ensure compliance with the IDEA, as required by 34 CFR §300.170(b) for the districts identified with significant discrepancies in FFY 2011.

The State did not report on whether it revised (or required the affected districts to revise), pursuant to 34 CFR §300.170(b), the districts’ policies, procedures, and practices relating to the development and implementation of IEPs, the use of positive behavioral interventions and supports, and procedural safeguards to ensure compliance with the IDEA for the districts identified with significant discrepancies in FFY 2012.

The State reported that it does not use a minimum “n” size requirement.

REQUIRED ACTIONS

The State did not report on whether it revised (or required the affected districts to revise) policies, procedures, and practices relating to the development and implementation of IEPs, the use of positive behavioral interventions and supports, and procedural safeguards to ensure compliance with the IDEA, as required in 34 CFR §300.170(b). In the FFY 2013 APR, the State must report whether, as a result of the review, the State revised, or required the affected districts to revise policies, procedures, and practices relating to the development and implementation of IEPs, the use of positive behavioral interventions and supports, and procedural safeguards to ensure compliance with the IDEA for the districts identified with noncompliance in FFY 2012.

Because the State reported less than 100% compliance (greater than 0% actual target data for this indicator) for FFY 2012, the State must report on the status of correction of noncompliance identified in FFY 2012 for this indicator. INDICATOR 9: The State reported that five districts were identified with disproportionate representation of racial and ethnic groups in special education and related services. The State also reported that no districts were identified with disproportionate representation of racial and ethnic groups in special education and related services that was the result of inappropriate identification.

The State provided its definition of “disproportionate representation.”

The State reported that 30 of 149 districts did not meet the State-established minimum “n” size requirement of 25 students with disabilities in any race/ethnicity category and were excluded from the calculation.

INDICATOR 10: The State reported that 33 districts were identified with disproportionate representation of racial and ethnic groups in specific disability categories. The State also reported that no districts were identified with disproportionate representation of racial and ethnic groups in specific disability categories that was the result of inappropriate identification.

The State provided its definition of “disproportionate representation.”

The State reported that 30 of 149 districts did not meet the State-established minimum “n” size requirement of 25 students with disabilities in any race/ethnicity category and were excluded from the calculation.

INDICATOR 11:

REQUIRED ACTIONS

Because the State reported less than 100% compliance for FFY 2012, the State must report on the status of correction of noncompliance identified in FFY 2012 for this indicator. In addition, the State must demonstrate, in the FFY 2013 APR, that the one remaining finding of noncompliance identified in FFY 2011 was corrected. When reporting on the correction of noncompliance, the State must report, in its FFY 2013 APR, that it has verified that each LEA with findings of noncompliance identified in FFY 2012 and each LEA with remaining findings of noncompliance identified in FFY 2011: (1) is correctly implementing the specific regulatory requirements (i.e., achieved 100% compliance) based on a review of updated data such as data subsequently collected through on-site monitoring or a State data system; and (2) has corrected each individual case of noncompliance, unless the child is no longer within the jurisdiction of the LEA, consistent with OSEP Memo 09-02. In the FFY 2013 APR, the State must describe the specific actions that were taken to verify the correction.

INDICATOR 12:

The State reported that the one finding of noncompliance identified in FFY 2010 was corrected.

REQUIRED ACTIONS

Because the State reported less than 100% compliance for FFY 2012, the State must report on the status of correction of noncompliance identified in FFY 2012 for this indicator. When reporting on the correction of noncompliance, the State must report, in its FFY 2013 APR, that it has verified that each LEA with noncompliance identified in FFY 2012 for this indicator: (1) is correctly implementing the specific regulatory requirements (i.e., achieved 100% compliance) based on a review of updated data such as data subsequently collected through on-site monitoring or a State data system; and (2) has corrected each individual case of noncompliance, unless the child is no longer within the jurisdiction of the LEA, consistent with OSEP Memo 09-02. In the FFY 2013 APR, the State must describe the specific actions that were taken to verify the correction.

INDICATOR 15: The State reported that the two findings of noncompliance identified in FFY 2010 and the remaining five findings of noncompliance identified in FFY 2009, FFY 2007 and FFY 2006 were corrected.

REQUIRED ACTIONS

In responding to Indicators 4B, 11, and 12 in the FFY 2013 SPP/APR, the State must report on correction of the noncompliance described in this table under those indicators.

INDICATOR 20: The State's FFY 2012 data for this indicator are 100%. However, OSEP recalculated the data for this indicator to be 95.65%.
