The State reported that no districts were identified as having a significant discrepancy, by race or ethnicity, in the rate of suspensions and expulsions of greater than ten days in a school year for children with IEPs.

The State reported that 214 of 230 districts did not meet the State-established minimum “n” size requirement of a minimum of ten students in any race/ethnicity and more than one student of any race/ethnicity with an IEP suspended or expelled.

INDICATOR 9: The State reported that no districts were identified with disproportionate representation of racial and ethnic groups in special education and related services.

The State provided its definition of “disproportionate representation.”

The State reported that 32 of 230 districts did not meet the State-established minimum “n” size requirement of greater than ten students in any race/ethnicity category for each disability and were excluded from the calculation.
