RMI FFY 2012 Results Data Summary Notes

INDICATOR 3B: RMI revised the improvement activities for FFY 2013 for this indicator and OSEP accepts those revisions.

RMI's FFY 2012 data represent slippage from the FFY 2011 data and RMI did not meet its FFY 2012 target for this indicator. Although RMI provided an explanation of the slippage, OSEP is concerned about the high percentage of students (71.4%) that did not participate in nationwide assessments.

RMI did not provide a Web-link to 2012 publicly reported assessments because RMI does not report these data for nondisabled children.

INDICATOR 3C: RMI did not provide a Web-link to 2012 publicly reported assessments because RMI does not report these data for nondisabled children.
