## New Jersey FFY 2012 Compliance Data Summary Notes

**INDICATOR 4B:** The State reported its definition of “significant discrepancy.”

The State reported that 19 districts were identified as having a significant discrepancy, by race or ethnicity, in the rate of suspensions and expulsions of greater than ten days in a school year for children with IEPs. The State reported that it reviewed the districts’ policies, procedures, and practices relating to the development and implementation of IEPs, the use of positive behavioral interventions and supports, and procedural safeguards to ensure compliance with the IDEA, as required by 34 CFR §300.170(b) for the districts identified with significant discrepancies in FFY 2011.

The State also reported that no districts were identified as having policies, procedures or practices that contribute to the significant discrepancy and do not comply with requirements relating to the development and implementation of IEPs, the use of positive behavioral interventions and supports, and procedural safeguards.

The State did not identify any noncompliance through this review.

The State reported that 587 of the 640 districts were not included in the calculation because they did not meet the minimum “n” size requirement of having five or more students of any racial/ethnic group, suspended for more than 10 days.

The State reported that the noncompliance identified in FFY 2011 through the review of policies, procedures, and practices, pursuant to 34 CFR §300.170(b), was corrected in a timely manner.

**INDICATOR 9:** The State provided its definition of “disproportionate representation.”

The State reported that 34 districts were identified with disproportionate representation of racial and ethnic groups in special education and related services. The State also reported that no districts were identified with disproportionate representation of racial and ethnic groups in special education and related services that was the result of inappropriate identification.

The State reported that a total of 134 districts did not meet the minimum “n” size of 25 children with disabilities above the expected number in the racial ethnic group analyzed.

**INDICATOR 10:** The State provided its definition of “disproportionate representation.”

The State reported that 40 districts were identified with disproportionate representation of racial and ethnic groups in specific disability categories. The State also reported that one district was identified with disproportionate representation of racial and ethnic groups in specific disability categories that was the result of inappropriate identification.

The State reported that 126 districts did not meet the State-established minimum “n” size requirement of 10 children with disabilities above the expected number in the racial ethnic group in specific disability categories. The State reported that it included all districts in the denominator for this indicator.

INDICATOR 11:

**REQUIRED ACTIONS**

Because the State reported less than 100% compliance for FFY 2012, the State must report on the status of correction of noncompliance identified in FFY 2012 for this indicator. When reporting on the correction of noncompliance, the State must report, in its FFY 2013 APR, that it has verified that each LEA with noncompliance identified in FFY 2012 for this indicator: (1) is correctly implementing the specific regulatory requirements (i.e., achieved 100% compliance) based on a review of updated data such as data subsequently collected through on-site monitoring or a State data system; and (2) has corrected each individual case of noncompliance, unless the child is no longer within the jurisdiction of the LEA, consistent with OSEP Memo 09-02.<sup>5</sup> In the FFY 2013 APR, the State must describe the specific actions that were taken to verify the correction.

The State reported that 36 of 37 findings of noncompliance identified in FFY 2010 were corrected. For the uncorrected noncompliance, the State reported on the actions it took to address the uncorrected noncompliance. The State explained that the remaining uncorrected FFY 2010 finding is a monitoring finding that is part of a lawsuit and subsequent settlement agreement in a large, urban district.

**REQUIRED ACTIONS**

The State must report, with the FFY 2013 SPP/APR, that it has corrected the remaining three findings of noncompliance identified in FFY 2011 and the one remaining finding of noncompliance from FFY 2010 that were not reported as corrected in the FFY 2012 APR..

When reporting with the FFY 2013 APR on the correction of the remaining findings of noncompliance identified in FFY 2011 and FFY 2010, the State must report that it verified that each LEA with remaining findings of noncompliance: (1) is correctly implementing the specific regulatory requirements (i.e., achieved 100% compliance) based on a review of updated data such as data subsequently collected through on-site monitoring or a State data system; and (2) has corrected each individual case of noncompliance, unless the child is no longer within the jurisdiction of the LEA, consistent with OSEP Memo 09-02.
