INDICATOR 4A: The State reported its definition of “significant discrepancy.” The State reported that no districts were identified as having a significant discrepancy in the rate of suspensions and expulsions of greater than ten days in a school year for children with IEPs.

The State reported that eight of 17 districts suspended/expelled students with disabilities for more than ten school days and six of these eight districts did not meet the State-established minimum “n” size requirement of having 25 or more students with disabilities who were suspended more than ten school days. The State also reported that in the two remaining districts the suspension/expulsion rate was lower than the statewide bar.

Nevada FFY 2012 Compliance Data Summary Notes

INDICATOR 4B: The State reported its definition of “significant discrepancy.”

The State reported that no districts were identified as having a significant discrepancy, by race or ethnicity, in the rate of suspensions and expulsions of greater than ten days in a school year for children with IEPs.

The State reported that eight of 17 districts suspended/expelled students with disabilities for more than ten school days and seven of these eight districts did not meet the State-established minimum “n” size requirement of having 25 or more students with disabilities, in any race/ethnic category, who were suspended more than ten school days. The State also reported that “in the remaining district, the district suspension/expulsion rate was lower than the statewide bar in each of the four race/ethnic categories where the district suspended/expelled 25 or more students with disabilities.”

INDICATOR 9: The State reported that no districts were identified with disproportionate representation of racial and ethnic groups in special education and related services.

The State provided its definition of “disproportionate representation.”

The State reported that two of 17 districts did not meet the State-established minimum “n” size requirement for any racial/ethnic group of 25 or more students in the special education population within the district.

INDICATOR 10: The State reported that no districts were identified with disproportionate representation of racial and ethnic groups in specific disability categories.

The State provided its definition of “disproportionate representation.”

The State reported that nine of 17 districts did not meet the State-established minimum “n” size requirement for any racial/ethnic group of having 25 or more students in the special education population or in a particular disability category within the district, and were excluded from the calculation.

INDICATOR 11:

REQUIRED ACTIONS
