INDICATOR 4B: The State reported its definition of “significant discrepancy.”

The State reported that zero districts were identified as having a significant discrepancy, by race or ethnicity, in the rate of suspensions and expulsions of greater than ten days in a school year for children with IEPs.

The State also reported that zero districts were identified as having policies, procedures or practices that contribute to the significant discrepancy and do not comply with requirements relating to the development and implementation of IEPs, the use of positive behavioral interventions and supports, and procedural safeguards.

The State did not identify any noncompliance through this review.

The State reported that 51 of 52 districts did not meet the State-established minimum “n” size requirement of 10 students with disabilities in a particular racial/ethnic category suspended greater than 10 days.

The State reported that all of the findings of noncompliance identified in FFY 2009 were corrected.

INDICATOR 9: The State reported that 16 districts were identified with disproportionate representation of racial and ethnic groups in special education and related services. Because the State reported less than 100% compliance for FFY 2012 (greater than 0% actual target data for this indicator), the State must report on the status of correction of noncompliance identified in FFY 2012 for this indicator.
