INDICATOR 8B: The State's FFY 2012 reported data for this indicator are 97.5%. However, OSEP recalculated the data for this indicator to be 0%.

The required measurement for Indicator 8B, effective for reporting on FFY 2012, is: "Percent = [(# of toddlers with disabilities exiting Part C where notification (consistent with any opt-out policy adopted by the State) to the SEA and LEA occurred at least 90 days prior to their third birthday for toddlers potentially eligible for Part B preschool services) divided by the (# of toddlers with disabilities exiting Part C who were potentially eligible for Part B)] times 100." (Emphasis added.)

The State reported that compliance for notification to the LEA was 97.5%, but that notification to the SEA would not occur until FFY 2013. Specifically, on page 27 of its FFY 2012 APR, the State reported that "ECI is currently working with TEA for the secure and timely notification at the state level of toddlers potentially eligible for Part B." The State confirmed that these notifications to the SEA were not yet occurring when it stated, "The implementation of the notifications will occur in the FFY 2013 APR reporting period. Notifications meeting the timeline will be reported in the next APR." Given that the State's FFY 2012 data for Indicator 8B do not reflect timely notification to the SEA (within 90 days of the toddler's third birthday), OSEP recalculated the State's data to be 0%.

Although the State reported less than 100% compliance for this indicator in FFY 2011, the State did not issue any findings of noncompliance in FFY 2011 for this indicator.
