REQUIRED ACTIONS

The State must report, with the FFY 2013 SPP/APR, that it has corrected that the one remaining finding of noncompliance identified in FFY 2011 that was not reported as corrected in the FFY 2012 APR.

When reporting with the FFY 2013 SPP/APR on the correction of the one remaining finding of noncompliance identified in FFY 2011, the State must report that it verified that the EIS program or provider with remaining findings of noncompliance: (1) is correctly implementing the specific regulatory requirements (i.e., achieved 100% compliance) based on a review of updated data such as data subsequently collected through on-site monitoring or a State data system; and (2) has corrected each individual case of noncompliance, unless the child is no longer within the jurisdiction of the EIS program or provider, consistent with OSEP Memo 09-02.
