> SUMMARY: We announce our intention to establish one or more negotiated

> rulemaking committees to prepare proposed regulations under Title IV  
> of the Higher Education Act of 1965, as amended (HEA). The committees  
> will include representatives of organizations or groups with interests  
> that are significantly affected by the subject matter of the proposed  
> regulations. We also announce three public hearings, at which  
> interested parties may suggest additional issues that should be  
> considered for action by the negotiating committees. In addition, for  
> anyone unable to attend a public hearing, we announce that the  
> Department will accept written comments.

> The Department will also be conducting forums after each of the  
> three hearings to discuss (1) how changes in the Department's  
> financial aid communications and processes (including the Free  
> Application for Federal Student Aid (FAFSA)) could improve college  
> planning, preparation and access, and (2) how best to leverage Federal  
> postsecondary programs to foster student educational persistence and  
> degree attainment.

> DATES: The dates, times, and locations of the public hearings are  
> listed under the SUPPLEMENTARY INFORMATION section of this notice. We  
> must receive written comments suggesting issues that should be  
> considered for action by the negotiating committees on or before June  
> 23, 2009.
