Meeting Summary

October 10-11, 2023

Welcome

Tamy Abernathy opening and introduction of Under Secretary James Kvaal introduction

Department of Education Under Secretary of Education James Kvaal thanked the Committee members for agreeing to assist the Department in developing the proposed regulations.

Tamy Abernathy introduced as the Federal Negotiator.

Tamy Abernathy provided the committee with an introduction of herself, an opening statement, and introduction of Mr. Ben Miller, Deputy Under Secretary in the Office of the Under Secretary.

Ben Miller addressed the committee with an opening statement.

Introductions

Commissioner Cynthia Jeffries of FMCS introduced the Department of Education General Counsel non-voting members: Brian Segal, Lead General Counsel (absent today), Soren Lagaard, who addressed the committee and introduced Toby Merrill who gave a brief statement to the committee.

The FMCS Team of Commissioners Cynthia Jeffries, John Weathers, and Mike Franczak introduced themselves. Commissioner Brady Roberts was absent from the sessions but will be joining the team for future meetings.

Committee members introduced themselves by virtue of rollcall.

Overview of the Negotiated Rulemaking Process

Commissioner Cynthia Jeffries, from the Federal Mediation and Conciliation Service (FMCS), explained and reviewed the negotiated rulemaking process, the virtual meeting technology, the protocols, consensus, and how to submit questions and information via the FMCS team.

Review and Adopt Protocols

The Committee approved the organizational protocols as proposed.

The Agenda

The first session's agenda included discussion focused around five questions.

Question #1 focused on: Are there ways to help borrowers who are in situations where they have seen their balances grow due to the accrual of unpaid interest such that many now have overall balances higher than what they originally borrowed.

Question #2 focused on: How could the department better assist borrowers who are eligible for forgiveness under programs such as income-driven repayment but who do not apply for those programs?

Questions #3 focused on: How should the Department consider debts taken out by students to attend programs when it was later found such programs did not provide a minimum level of financial value sufficient to make loans affordable.

Question #4 focused on: How should the Department treat loans that first entered repayment

many years ago, including will prior to the creation of additional benefits? How should the Department apply the FCCS compromise principle to loans that the borrower is unable to repay in a reasonable amount of time.

Question #5 focused on: What are potential types of hardship that borrowers may continue to face and how might the Department address those cases of hardship?

Discussion of Questions

There was discussion beginning with the Department reviewing the background associated with each question one at a time. Then, Committee members had the opportunity to engage with the Department directly to offer their interests, concerns, preferences, and possible solutions relative to each question.

Public Comment

The Committee provided opportunity for public comment at the end of each day. Public comment was received on both days of the session.

FMCS will distribute a final summary and a final agenda to the negotiators. In addition, the Department will distribute draft regulatory policy text prior to the next negotiation session.
