PROGRAM

As you are aware, Sections 75.118 and 75.590 of the Education Department General Administrative Regulations (EDGAR) requires recipients of multi-year discretionary grants to submit an Annual Performance Report (APR) to determine if substantial progress has been made to the scope and objectives established in the approved application and any approved amendments.

In Fiscal Year (FY) 2018, two performance reports are required. The **first** performance report required, a Semi-Annual Performance Report (SAPR), is due on **May 4, 2018**. For the SAPR, using ED 524B, please provide a brief update on progress towards meeting project objectives. If your budget burn rate is slower than expected, please provide a narrative explanation for the slow drawdown of funds and a plan for executing those funds (request to carry over funds) (see Sample Budget below). The SAPR must be submitted via G5. You can access G5 through ED's G5 portal page by using the following web site: http://www.g5.gov. Please follow the instructions on ED 524B Forms (Section A) Executive Summary and (Section B) Project Status.

The **second** performance report required is an Annual Performance Report (APR) due **September 28, 2018**. The APR should include a full update on progress towards meeting goals and objectives for the current twelve month budget period and should provide data for the required GPRA measures. Other pertinent data that was not included in the SAPR should be provided in the APR.

- ➤ **Proficiency Measure** The percentage of Native Hawaiian students in schools served by the program who meet or exceed proficiency standards for reading, mathematics, and science on the State assessments;
- ➤ Early Childhood Measure The percentage of Native Hawaiian children participating in early education programs who consistently demonstrate school readiness in literacy as measured by the Hawaii School Readiness Assessment (HSRA);

- ➤ **High School Measure** The percentage of students in schools served by the program who graduate from high school with a high school diploma in four years; and
- ➤ Hawaiian Language Measure The percentage of students participating in a Hawaiian language program conducted under the Native Hawaiian Education Program who meet or exceed proficiency standards in reading on a test of the Hawaiian language. All grantees will be expected to submit an annual performance report addressing these performance measures, to the extent that they apply to the grantee's project.
