The Rehabilitation Services Administration (RSA) acknowledges your electronic submission of the State Plan for the Title I Vocational Rehabilitation (VR) Services Program and Supplement for the Title VI-B Supported Employment (SE) Services Program in the form of a preprint of affirmative assurances and required attachments on behalf of Florida Division of Vocational Rehabilitation (FDVR) in compliance with Sections 101(a) and 625 of the *Rehabilitation Act of 1973*, as amended (the Act).

The State Plan, in the form of a preprint of affirmative assurances and required attachments, was reviewed to ensure conformity with statutory provisions of the Act, implementing regulations and the administrative requirements of RSA. 
